

Nomination Form 3 – Best Bank Financing the Industry

Key Instructions:

- These award categories recognise banks for their support to the gems & jewellery sector **by way of export financing**.
- The nomination form has been designed to capture data pertaining to the quantum of lending made by banks to the gems & jewellery sector. However, please note that this **does not include non-funded credit facilities**.
- The year to be considered for awards is the financial year of 2015-16 and 2014-15, i.e. from 1st April 2015 to 31st March 2016 and from 1st April 2014 to 31st March, 2015.
- Nominations are open for all types of banks - Scheduled Commercial Banks, Urban cooperative Banks, Regional Rural Banks, Co-operative Banks, etc.
- The nomination form should be signed and stamped by an authorised signatory of the bank.
- The details furnished in the nomination form should also be certified by a Chartered Accountant by filling out the Chartered Accountant Declaration in the nomination form. Nomination forms with incomplete C.A. declaration details will not be considered for the awards.
- Financial details will be kept confidential and used only for computation purpose
